# **Course Description:**

This course juxtaposes competing explanations for the patterns of conflict and cooperation among states, illustrated by the relations among the great powers of Europe and Asia during the last few centuries. Topics to be covered include conceptual frameworks with which to make sense of international relations; balance of power and polarity issues; trade; regional organizations and non-traditional security challenges.
